### Reports

**Chair's Report** – All is well.

**Secretary Report-** Minutes were on the web within 36 hours of Area Service last time. All is well.

**Treasurer Report-** The balance brought forward of the Area's Treasury on March 8, 2014 was one hundred four dollars and twenty-two cents (\$104.22). **Living With Hope** donated ten dollars (\$10.00). Rent in the amount of ten dollars (\$10.00) for use of our meeting space was given to Mary Jo V., GSR for **Turning Point**. This leaves a balance of one hundred four dollars and twenty-two cents (\$104.22). The AT&T invoice for March 5<sup>th</sup> through April 4<sup>th</sup>, 2014 indicated a \$3.92 (three dollar and ninety-two cents) charge for the month instead of the usual twenty-three dollars and nine cents (\$23.09). I contacted their

Customer Service on March 24<sup>th</sup>, 2014 at 12:42 p.m. and spoke with Jasmine asking what our monthly charges should be for our line. After reviewing our invoice, she indicated that she did not understand why we were only charged the three dollars and ninety-two cents (\$3.92) and advised me that if we wanted to pay through the end of the year 2014 to do so as the twenty-three dollars and nine cents (\$23.09) per month rate. The AT&T invoice for April 5<sup>th</sup> through May 4<sup>th</sup> indicated that we were back to the usual twenty-three dollars and nine cents (\$23.09) charge for the Info Line. This leaves us with a credit balance of nineteen dollars and seventeen cents (\$19.17). I would suggest that we leave the motion for paying AT&T one hundred eighty-four dollars and seventy-two cents (\$184.72) as it was originally submitted. This would cover our bill until the beginning of 2015. If the billing error is corrected the balance in the account at present would cover it. If not, then we will have a credit balance going into the year 2015. In Loving Service, Deb F.
