New Business – *Motion* – Carrying the Message / 2nd by Gratitude - Serenity Coast Area to pay the AT&T Info Line bill through the end of the year 2014. The most recent bill received was for the billing cycle February 5 through March 4, 2014. The invoice indicated the charge was twenty-three dollars and nine cents (\$23.09) for the month with a credit balance of forty-six dollars and eighteen cents (\$46.18). This means that March 5th through April 4th and April 5th through May 4th will be covered with the current credit balance. In order to pay May 5th through January 4th, 2015 at the current monthly rate this would be a total of one hundred eighty-four dollars and seventy-two cents (\$184.72). As there is only one hundred four dollars and twenty-two cents (\$104.22) in Area Treasury at this time, some funds would need to be donated by the groups to pay this bill.
