Reports

Chair's Report – All is well.

Secretary Report – All is well.

Treasurer Report – The balance brought forward of the Area Treasury on March 12th, 2012 was one hundred eight dollars and eighty-nine cents (\$108.89). Three groups **In the Wind** (\$50.00), **A Gift of Life** (\$40.00), and **Carrying the Message** (\$10.00) donated a total of one hundred dollars (\$100.00) to the area. Rent in the amount of ten dollars (\$10) for use of our meeting space was given to Dave V., GSR for **Turning Point** Group. This leaves a balance of one hundred ninety-eight dollars and eighty-nine cents (\$198.89)
AT&T sent a bill on June 5th, 2012 showing the monthly charge as forty dollars and twenty cents (\$40.20) which left us with a credit balance of one dollar and eighty cents (\$1.80). This bill covered June 5th, 2012 through July 4th, 2012. We have recently received a bill for July 5th through August 4th, 2012 in amount of forty dollars and twenty cents (\$40.20). We now have a balance with AT&T of thirty-eight dollars and forty cents

(\$38.40). As the groups have decided to make quarterly payments for the information Line, the billing cycle for the next three months will be as follows:

July 5 – Aug. 4, 2012	\$38.40 (\$40.20 less \$1.80 credit balance)
Aug. 5 – Sept. 4, 2012	\$40.20
Sept 5 – Oct. 4, 2012	<u>\$40.20</u>
Total for 3 Months	\$118.80

I will secure a Cashier's Check on Monday, July 23, 2012 in the amount of one hundred eighteen dollars and eighty cents and mail to AT&T. We will need to keep in mind that we are paying (\$10.00) in rent for each ASC meeting out of the Area's Treasury.
