Secretary Report- I'm sorry for the minutes for the last ASC meeting were late. I apologize to all the GSRs that called and sent text messages to me looking for the minutes so that their home groups could have them for their group conscience. I had sent the minutes to the Area Chair to proof read on August 8th, 2013. At the last ASC meeting, I reported that I was stepping down as Secretary as I have served for more than a year in that position. After speaking with my sponsor and others that have been a part of the Serenity coast area since its beginning, I have decided to wait until January to step down so that the Executive Officers (Chair, Secretary, and Treasurer) will be on the same term schedule. Treasurer Report: The balance brought forward of the Area's Treasury on July 20, 2013 was two hundred fifteen dollars and eighty-five cents. Four groups: **By the Book: (\$10.00), It Works, We Do Recover (\$10.00), Just Say No, (\$10.00) and Safe Haven (\$10.00)** donated a total of forty dollars (\$40.00) to the area. Rent in the amount of ten dollars (\$10.00) for use of our meeting space was given to the GSR for the **Turning Point** Group. This left a balance of two hundred forty-five dollars and eighty-five cents (\$245.85). The Current AT&T bill for the info line reflects a balance of \$0. Upon the outcome of the Serenity Coasts groups vote on the motion to pay 7 months in advance, I will be making a payment of AT&T either in the amount of \$161.63 (7 months) or \$69.27 (3 months).
